#### 45 HIGHWAYS AND TRAFFIC

- .1 | Bus service survey / request recap / update
  - Following resident's request to March Parish Council meeting for support for a bus service, a Survey Monkey questionnaire received 54 responses; 48 (90%) responded 'yes' to Q1: 'Do you think Heckfield needs a bus route to Hook?' The majority gave reasons as travel for college or shopping. This feedback was forwarded to Stagecoach and received relatively positively. Or at least they didn't immediately say no, but wish to see more data for potential demand.
- Actions the following circulated 16 August via Heckfield WhatsApp, Hound Green WhatsApp, Mattingley Matters Facebook ...

'If you wish to have a bus route between Riseley and Hook via the B3349/Odiham Road please can you email or call Stagecoach – customer.services@stagecoachbus.com or 0345 241 8000 – explaining your needs for transport. There has to be sufficient demand to make this financially viable for Stagecoach. Please share.'

Further action – to circulate to Dukes Meadow and Riseley WhatsApps etc (DK); to Mattingley/Chandlers Green Whatsapp (ST).

- ii Cllr Davies reported that HCC have reduced their overall bus subsidy by £1M.

- **Ditch by Church Lane south** Drawings supplied by BT PLC **APPENDIX V.** Drawings confirm the OpenReach cable connecting School Lane to Church Lane follows the route of Church Lane south but where exactly the cable is? Any ditch clearing will need to be by hand with care.
- **Trees by School Lane** (Owned by HCC) Contact established (BH) with HCC's Assistant Arboricultural Officer, but no positive response regarding work to the trees.
- Action BH to forward correspondence to Cllr Davies copied to clerk. Tim will write to officer, copied to relevant cabinet members (HCC and Hart).
  - Discussion Trees not been cut in 10 years local power lines go through said that if not a power outage SSEN not going to touch trees overshadow all road, take all light, can't see moonlight killing 290 year-old yew hedge bin lorries bring down branches which catch on the top of the trucks when the school bus a double decker it wouldn't come down School Lane because of the trees.

#### .7 | Highways - general

- Drifting at Wellington roundabout DK reported some road racing continuing despite dry weather and so associated small of burning tyres. Every road sign in middle roundabout is now broken.
- ii A33 into Berkshire Evidently more subsidence; a lot of resurfacing done but the subsurface not sufficiently compacted when the road was built. Cllr Davies will report to relevant unitary councillor.
- Bin on B3349 near A33 roundabout. Contact received from Riseley resident (mid-May) as the bin not being emptied. Not belonging to Hart; bin and rubbish removed 28 May. Reported at the meeting that another unofficial bin been placed by B3349 ?? collecting rubbish but won't be emptied.

'Following review and official go-ahead from Cabinet of 2nd January 2025, project planning has been undertaken as a preliminary step towards a New Local Plan for Hart.

'A report will be submitted to Overview & Scrutiny Committee of 04 September and then to Cabinet of 16 September, to consider work to date and next steps.

'Subject to Cabinet approval, a new Local Development Scheme [Local Plan Update Schedule] will be published replacing the current LDS ninth revision.

'A New Local Plan would replace the current Hart Local Plan to 2032 (adopted April 2020) and Saved Policies from the Hart Local Plan (Replacement) 1996-2006.'

#### 48 FURTHER REPORTS

- **Parking in Hartley Wintney**; numbers of free parking bays are being reduced (unreasonably); Cllr Davies will pass on concerns.
- Village Gateway project (2022/23) put on hold due to cost and other demands on finances. However new residents in the Village are also raising the issue that, for drivers on the B3349, it's not apparent that driving through a Village. Hampshire County Council input and permission is required for Gateways / signage as on land covered by Highways rights, and particularly as on a busy B road. Cllr Davies elected to broach the question with Local Highways Engineer.
- .3 | Local Government Reorganisation Final proposals from First and Second Tier Councils:
  - 1. Joint proposal from County and East Hants for three mainland unitaries including a 'Mid and North' Hants Unitary of Hart, Rushmoor & BDBC, with East Hants and Winchester.
  - 2. Proposal from ALL other councils (bar Gosport) for four mainland unitaries which includes a Northern Hants Unitary comprising Hart, Rushmoor & BDBC.

Consultations ended 17 August; all 15 first and second tier councils must submit their own proposal – to Government by 26 September – for all the Hants and Solent area.



No need to return to the unit for data retrieval; just access over the internet using your inclusive dashboard, which is set up after installation. The local Community Speedwatch coordinator can then invite members of the local community to be involved in verifying and using the data collected.

Please see About AutoSpeedWatch for more detail. The very presence of the system works as a deterrent and modifies driver behaviours. Useful statistics are also available from the unit but, if you want 24hr traffic survey data, you will get better results with a dedicated traffic logging device.

Installation is simple and quick. This AutoSpeedWatch Roadside unit is designed for mounting on a sturdy vertical roadside pole of at least 76mm diameter and is mounted such that it takes a picture of the rear of a passing speeding vehicle. Each unit comes complete with a high-security fixing suitable for poles of diameter 76mm-120mm, but other fixings are available in our accessories category.

As with all public facing cameras you'll need to adhere to the BSCC guidelines and we advise you to use special signs to assist doing so; it's not onerous and we even provide draft Data Protection Impact Assessment and Camera Policy to assist you (when your order is complete go to "My Account" > "My Orders" > "Downloads" to retrieve). Most forces understand the benefits the system brings and will support you. You do not require their approval, however we suggest you check what response can be expected before purchasing. You will however need Highways approval to install on the highway (but not on private land).

The first year (from date of purchase) of data connectivity is included. 2nd and subsequent years will require a data plan to maintain connectivity and access to the system; this being the only on-going cost; there are no other subscription-type costs, and maintenance is usually just a case of keeping the unit clean! Autospeedwatch Limited and its use of the system has been certified compliant with the guidelines and the BSCC codes of practice.
